2. Occupational Safety and Health

RB-Messwerkzeuge GmbH is firmly convinced that the safety and well-being of its employees are critical to the company's economic success.

We place great emphasis on adhering to our safety and health guidelines and are dedicated to continuously promoting the physical and mental well-being of our workforce.

Therefore, RB-Messwerkzeuge GmbH ensures a healthy and hazard-free work environment by complying with workplace safety laws and implementing appropriate procedures and protective measures to safeguard health in the workplace.

2.1 Appointees and First-Aiders

According to Section 22 of the 7th Social Code, employers are required to appoint safety professionals, safety officers, and first-aiders. The law states:

"In companies with more than 20 regular employees, the employer, in collaboration with the works council or staff council, must appoint safety officers, taking into account the company's accident and health risks and the number of employees."

These appointees are responsible for supporting the employer in implementing measures to prevent accidents, particularly by ensuring the presence and proper use of mandated safety equipment and personal protective gear, as well as identifying hazards for employees.

Appointees must not face any disadvantages due to the fulfillment of their assigned duties.

2.2 Emergency Preparedness

The designated first-aiders at RB-Messwerkzeuge GmbH are the specially trained persons to contact in the area of emergency preparedness. First-aid training should be repeated at least every two years at the company's expense.

First-aiders regularly inspect the availability and functionality of first-aid equipment (e. g. bandages, stretchers) and advise management on the implementation of the GUV- V A 5 First Aid regulations. This ensures that emergency aid measures are effectively executed in the event of an actual emergency.

2.3 Accident and Disruption Management

The designated safety officers at RB-Messwerkzeuge GmbH are the specially trained evacuation officers in the area of accident and disruption management.

Safety officers regularly inspect emergency exits, escape routes, and the designated assembly point to ensure they are in proper condition. They are also responsible for displaying and regularly updating the company's internal emergency plan.

In the event of an accident or disruption, the safety officers and first-aiders are responsible for alerting personnel in their assigned areas. Additionally, they are responsible for guiding employees to the assembly point and, if necessary, conducting an attendance check to ensure everyone is accounted for.

2.4 Workplace Ergonomics

RB-Messwerkzeuge GmbH is committed to adhering to ergonomic principles in workplace design, in accordance with Section 5 of the German Occupational Safety and Health Act (*Arbeitsschutzgesetz*), to promote both employee well-being and the company's operational efficiency.

Our goal is to create a work environment that is humancentered, ensuring that employees are neither physically underchallenged nor overburdened, whether in the short or long term. In doing so, ergonomically optimized work conditions are intended to increase the likelihood of achieving high-quality work results.

2.5 Fire Protection

The fire protection regulations for RB-Messwerkzeuge GmbH are based on:

- the State Building Code (Landesbauordnung),
- the Workplace Ordinance (Arbeitsstättenverordnung), and
- the accident prevention regulations (particularly the Principles of Prevention (GUV-VA1).

A key aspect is ensuring that during the annual safety training sessions, the employees of RB-Messwerkzeuge GmbH are regularly informed about the fire safety regulations, with a particular focus on proper behavior in the event of a fire. This knowledge is reinforced through regular evacuation drills.

The Safety Officer conducts periodic inspections to ensure that fire protection equipment, such as fire extinguishers and fire blankets, is present and in proper working condition. They also verify the quantity and fire classification of the extinguishers, initiate initial fire containment if necessary, and coordinate with the fire department upon arrival, providing critical information about hazards at the fire scene.

2.6 Hazardous Substances

The following regulations are designed to ensure the safe handling of hazardous substances at RB-Messwerkzeuge GmbH.

These guidelines govern the procedures for handling hazardous substances as well as their secure storage and safekeeping.

Key regulatory foundations include:

- the Chemicals Act (Chemikaliengesetz)
- the Hazardous Substances Ordinance (*Gefahrstoffverordnung*),
- additional technical standards.
- accident prevention regulations,
- rules established by statutory accident insurance providers, and
- technical regulations for operational safety.
